### OER (TER) 2020-2021

### **Article 2 – Concepts**

Article 2 is supplemented with Section 4 and reads as follows:

4. A written or oral examination can also be administered digitally and/or online. Where these Regulations refer to examinations, this also refers to digital and/or online examinations.

# **Article 3 - Admission to Bachelor's degree programmes**

(Art. 7.25 and 7.28 WHW) BoS advisory powers

Tweede Verzamelspoedwet COVID-19

Article 3 is supplemented with Sections 3a and 3b concerning conditional admission, and reads:

### VO -> bacheloropleiding

- 3a. For the 2020-2021 academic year, in addition to Section 1 of this article, students referred to in Subsection a of this Section may be admitted conditionally provided that they make it plausible that, before 1 January 2021, they:
  - have successfully completed the NT2-II language exam, or
  - have passed the state examination in Dutch as a second language or have otherwise demonstrated that they meet the required language level, and
  - have eliminated any other deficiencies by taking one or more state exams.

If, on 1 January 2021, they do not meet the conditions for admission referred to in Subsection 1a of this article, they will be unenrolled from the degree programme.

#### HBO propedeuse -> bacheloropleiding

- 3b. For the 2020-2021 academic year, in addition to Section 1 of this article, students referred to in Subsection b of this Section may be admitted conditionally provided that they:
  - By 1 August 2020 at the latest, TU Delft has received a completion recommendation from their HBO (University of Applied Sciences) showing that it is likely they will successfully complete the relevant first year before 1 January 2021, and
  - on the basis of which the degree programme has made a positive assessment and
  - Bachelor Eindproject (Bachelor End Project / BEP / KTO)

If, on 1 January 2021, students have not met the admission requirements referred to in Section 1b of this article, they will be unenrolled from the degree programme.

#### Article 3- Admission to the Master's degree programme

(Art. 7.30b WHW) BoS advisory powers

Article 3 is supplemented with Section 3 (conditional admission), which reads:

- 3. For the 2020-2021 academic year, in the context of the outbreak of COVID-19, students who were enrolled at a Dutch university or HBO (University of Applied Sciences) in the 2019-2020 academic year may be conditionally admitted provided that, on 31 August 2020, they:
  - have a deficit not exceeding 15 ECTS for the Bachelor's degree audit of the Bachelor's programme referred to in this article, or

- have a deficit not exceeding 15 ECTS for completion of the bridging programme referred to in this article, but
- have in any event successfully completed at least the following components: [specify substantive entry requirements here]

If, on 31 August 2021, students have not met the admission requirements referred to in Section 1 of this article, they will be unenrolled from the degree programme.

# Article 13 - Registration for written examinations FSC right of approval; BoS advisory powers

Article 13 Section 1 is supplemented with the following sentence in italics, and reads:

1. Registration to participate in a written examination is compulsory and is done by entering the requested data into Osiris no later than 14 calendar days before the examination. Students receive examination tickets by email as confirmation of their registration. Contrary to the first sentence, for an written examination, a registration period of no later than 6 calendar days before the examination date applies.

Article 13 is supplemented with Sections 6 and 7, which read as follows:

- 6. Sections 2 and 4 of this article do not apply to a written examination administered online remotely from the university.
- 7. If unforeseen circumstances or measures, for example as a result of COVID-19, necessitate a change in the form or manner of taking the examination, the original registration period will remain in full force, unless the Dean decides on a different registration period for the benefit of the student.

### Article 14 - Registration for other examinations FSC right of approval; BoS advisory powers

Article 14 Section 1 is supplemented with the sentence in italics below, and reads:

 Registration for participation in an examination other than a written examination is compulsory, and it is done in the manner and within the term that is stated in the study guide for the relevant examination. If, due to unforeseen circumstances or measures, for example as a result of COVID-19, the form or manner of taking the examination changes, what is stated in the study guide will apply in full, unless the Dean decides to deviate from the manner or term for registration prescribed in the study guide.

# Article 16 - Form of the examinations and the manner of testing in general (Art. 7.13 Section 2, Subsections h and I WHW)

FSC right of approval, BoS advisory powers

Article 16 Section 1 is supplemented with the sentences in italics below, and reads:

1. Examinations (oral, written or otherwise) are taken in the manner described in the appendix. *Unforeseen circumstances or measures, for example resulting from COVID-19, may require deviation from the prescribed form. If an examination is administered using online proctoring, this must take place in accordance with the TU Delft Online Proctored Examination Regulation.* 

# Article 18 - Oral examinations (Art. 7.13 Section 2, Subsection n WHW) FSC right of approval, BoS advisory powers

Article 18 Section 3 is supplemented with the sentence in italics below, and reads:

3. The oral examination is administered by at least two examiners. *In the event of unforeseen circumstances or measures, for example as a result of COVID-19, the oral examination can be administered by a single examiner, in which case the oral exam is recorded on sound and/or image.* 

# Article 27 – (Negative) binding recommendation on the continuation of studies

Article 27 is supplemented with Section 10. This reads as follows:

10. Students who obtained fewer than 45 credits in their first year of the degree programme in the 2019-2020 academic year and for whom the binding recommendation on the continuation of studies has been automatically postponed as a result of the amended regulation for the binding recommendation on the continuation of studies for the 2019-2020 academic year in the context of COVID-19, must have obtained all remaining credits from the first year of the degree programme in the subsequent academic year. Students who have not obtained all remaining credits by the end of the subsequent academic year will receive a final negative binding recommendation on the continuation of studies.

# **Article 29 - Amendments to the regulations**

A fourth Section is added to Article 29. This reads as follows:

4. As a result of unforeseen circumstances or measures, for example as a result of COVID-19, the Dean may decide to deviate from these regulations, including the actual design of the education and any compulsory attendance requirements. This also means that it is possible to deviate from the provisions of the study guide.

# **Article 10** Administering examinations

Article 10 Section 4 is supplemented with the clause in italics below, and reads:

4. In the event of unforeseen circumstances, the examination may be taken or retaken in a different way or at a different time, *and the way in which the result of an examination is indicated can be changed.* The Board of Examiners will decide on this matter in consultation with the examiner.

## Article 11 Online proctored examination

Article 11 is replaced with:

## **Article 11** Online proctored examination

An examination can be administered using online proctoring

- a) if no other means of examination is possible, and
- b) if this takes place in accordance with the TU Delft Online Proctored Examination Regulation.

# **Article 13** Procedure during examinations

The last sentence of Article 13 Section 1 is amended to read as follows:

1. The examiner will ensure that invigilators are appointed for an examination who will supervise the examination on behalf of and under the responsibility of the Board of Examiners to ensure that examination proceeds properly. When an examination is administered in an examination room, the invigilator will observe the "Rules of Procedure for Examinations" (Reglement van Orde bij Tentamens), which are available in the examination room.

# Article 14 Assessment

Article 14 Section 8 is supplemented with the sentence in italics below, and reads:

8. If more than one result is earned for a course, the highest result that has been earned will apply during the degree audit, on the understanding that in the case of a 'pass' and a 'Satisfactory' mark or higher, only the mark applies.
