As I see it, if there are three exams, then nobody should be able to complain. If we really want to offer it in Q3 but honor the prior announcement that it would be held in Q4, then how about:

-We offer it as originally planned in Q3

-We offer it at the end of Q4 in the extra exam week (6-10 July)

-We offer it again at the end of the Summer/early Fall as a make-up.

The requirement would be that any given student can only attempt two of them

That way, we can do as many as possible in Q3 but not distress the students who are now preparing for it to be in Q4.
